

Market today: Derivative maturity*(Phuong Nguyen – phuong.nh@vdsc.com.vn)*

- *The market was supported at 1,115 points and recovered at the end of the session.*
- *It is expected that exploration developments in the 1,115 - 1,130 point area will continue in the near future before there are more specific signals.*

After the disputed state of the previous session, the market had cautious movements in the expiration session of Contract VN30F2311. The market moved in the red price zone for most of the trading time and only rebounded at the close. At the end of the session, VN-Index increased 3.03 points (+0.27%), closing at 1,125.53 points. Matching liquidity decreased with 605.1 million shares matched on HOSE.

VN30 group increased 0.7 points (+0.06%), closing at 1,132.6. In the group, there were 16 gainers such as SAB (+1.6%), PLX (+1.3%), SSI (+1.1%), BVH (+1%), GVR (+1%) ... On the contrary, there were 14 losers, namely TPB (-1.1%), VRE (-1%), MWG (-1%), BID (-0.9%), VIC (-0.7%)...

With cautious developments on low liquidity, the divergence was quite clear during the session and slightly improved when the market recovered at the end of the session. The highlight of the session was Chemical with many good advancers, besides Securities, Construction, Steel, Transportation - Warehousing... also had recovery movements.

Foreign investors returned to net selling on HOSE, with a value of 124.8 billion VND. In particular, they sold strongly at VHM (-87.9 billion), MWG (-80.8 billion), VNM (-66.9 billion), VRE (-56.1 billion), FRT (-34.1 billion) ... In the opposite direction, they bought a lot in SSI (+43.2 billion), KBC (+27.7 billion), DIG (+24.4 billion), VIX (+23.5 billion), VND (+ 22.4 billion).

The market was supported at MA(200) area of 1,115 points, when it retreated and recovered at the end of the session. Liquidity decreased compared to yesterday's, showing the cautious state of cash flow, especially in the expiration session of Contract VN30F2311. However, the supply situation at low prices is temporarily limited and has not yet put great pressure. The market is still in the exploration phase at 1,115 - 1,130 points after a strong rebound session. It is expected that this development will continue in the near future before there are more specific signals. However, It's worth noting that supply will be under pressure again as market rises. Therefore, investors should slow down to observe the state of supply and demand. Currently, it is possible to take advantage of the market's ability to increase to take profits or restructure the portfolio.

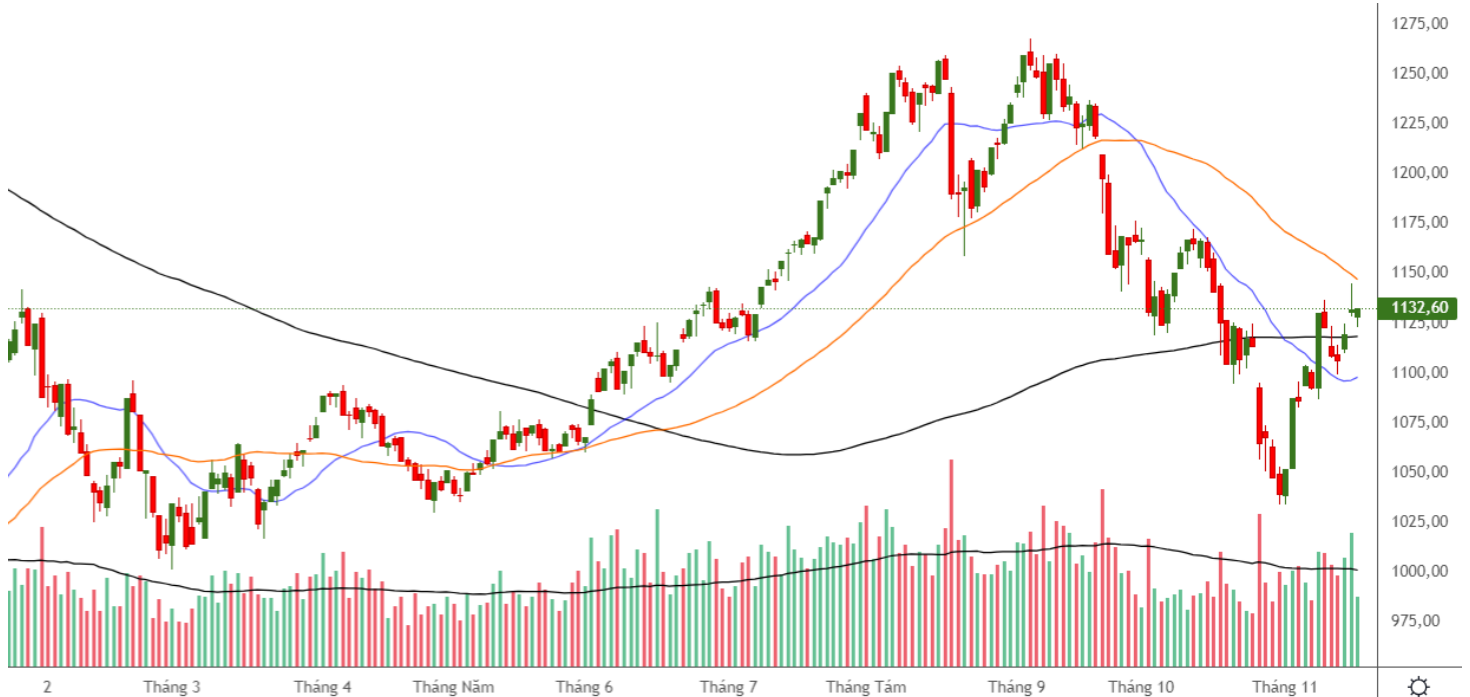
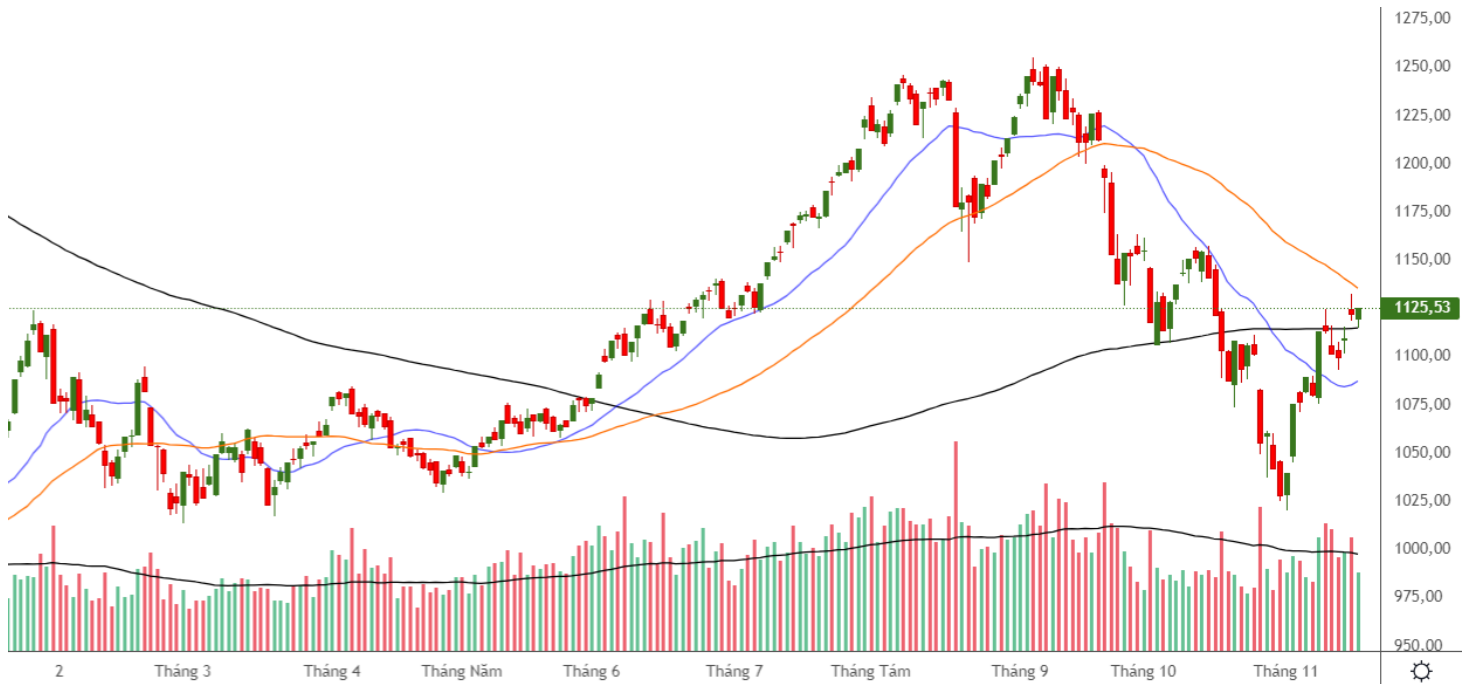
