**Market today: Maintain the upward momentum**

- The market continued to increase despite pressure from the 1,270 - 1,275 area and slightly exceeded the MA (20).
- It is expected that the market will temporarily fluctuate in the area of 1,270 - 1,280 points in the near future.

The market continued to be in green as it entered the new trading session. The increase in points slowed down somewhat and at times the market retreated to the red price zone. However, the market tried to maintain balance and continued to prosper in the afternoon session. VN-Index increased 7.06 points (+0.56%), closing at 1,276.85 points. Matching liquidity increased with 502 million shares matched on HOSE.

VN30-Index increased 9.44 points (+0.73%), closing at 1,305.5 points. In the group, there were 20 gainers such as POW (+4.1%), BID (+3.2%), TCB (+2.6%), FPT (+2.3%), HDB (+1.7%) ... On the contrary, there were 6 losers, namely VRE (-1.8%), BVH (-1.3%), MWG (-0.8%), VIC (-0.6%), VIB (-0.2%), VHM (-0.1%).

In an effort to maintain the market's rising pace, many stock groups continued to be in green. Banking, Technology, Electricity, Chemical groups... had exciting developments and actively supported the market.

Foreign investors continued to be net sellers on HOSE, with a value of 536.5 billion VND. In particular, they sold strongly at VRE (-414.3 billion), VHM (-99.3 billion), MWG (-87 billion), HPG (-54.2 billion), DCM (-18.8 billion) ... However, they bought a lot at BID (+76.8 billion), HDB (+36.8 billion), VPB (+34 billion), MSN (+19.5 billion), SIP (+18.9 billion)...

*The market continued to increase despite pressure from the 1,270 - 1,275 area and slightly exceeded the MA (20). Liquidity increased compared to the previous session, showing that there was a dispute between supply and demand but in general the supply pressure was not high. The growth rate shows signs of slowing down because the price increase has occurred quite rapidly in the past 3 sessions. It is expected that the market will temporarily fluctuate in the area of 1,270 - 1,280 points in the near future. However, the uptrend may still continue after this tentative state thanks to the support from recent developments. Therefore, investors need to slow down to observe supply and demand, but can still consider good price ranges of some stocks for short-term investment. In addition, it is still necessary to consider the market's recovery to take profits or structure the portfolio to minimize risks.*

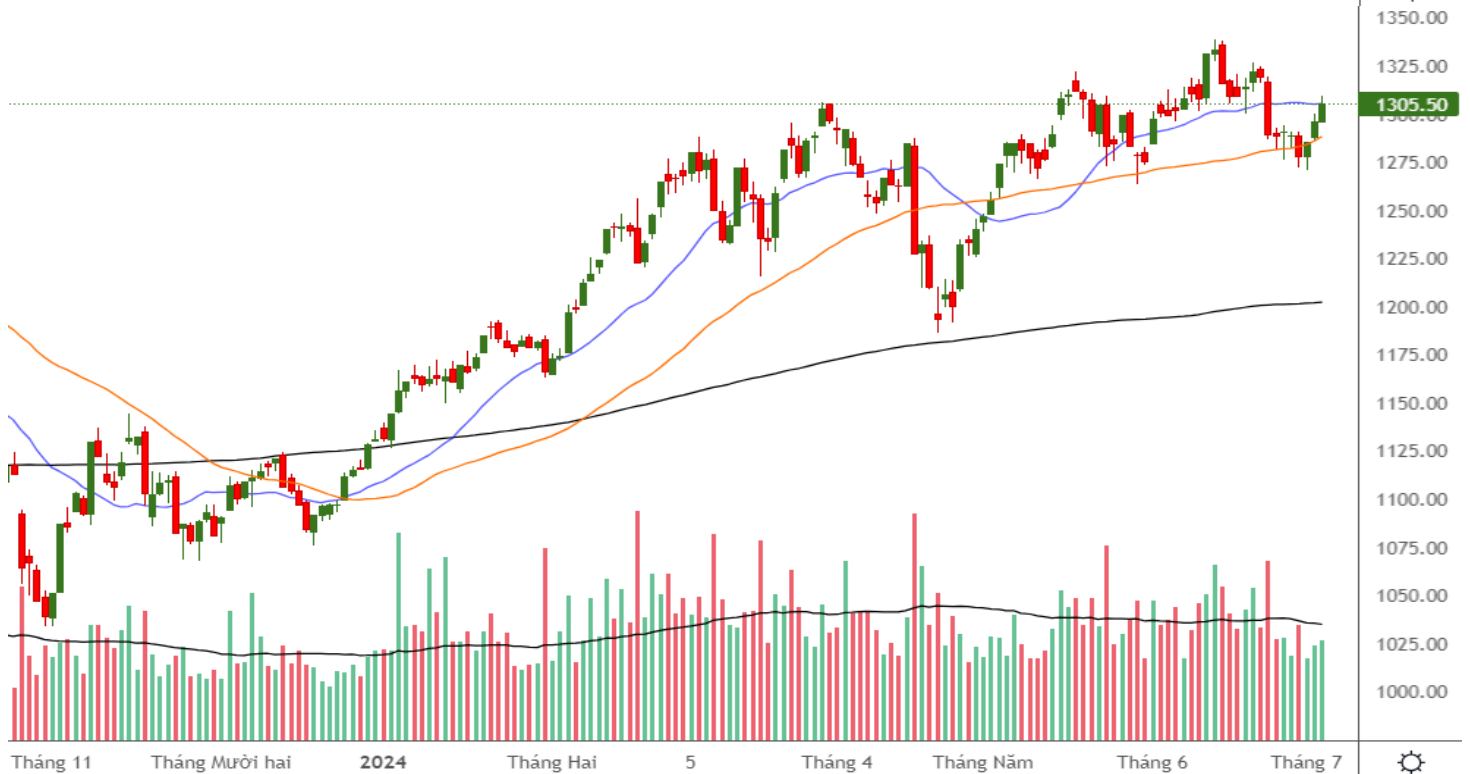
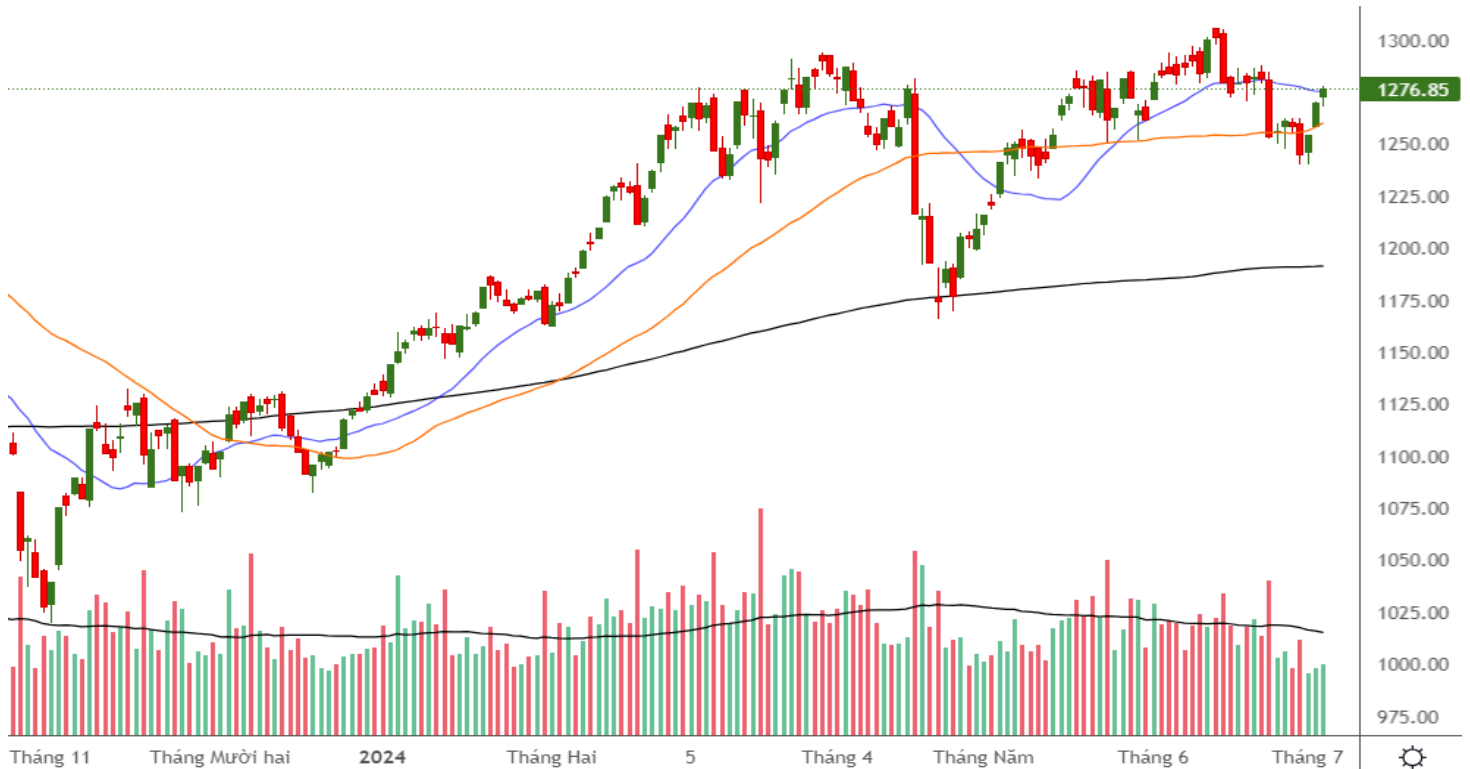
