Market today: Rising start of the year

- The uptrend is somewhat slowed down before the profit taking supply, shown by the Shooting Star candle. Market still remained in green at the end of the session, showing that the pressure of supply is not great.
- It is expected that the market will temporarily step back in the next session to find a balance after the recent increase.

Following the uptrend before the holiday, market started the Year of Cat with many advancers. Despite being cautious and retreating in the afternoon session, market still remained in green. VN-Index gained 9.02 points (+0.81%) and closed at 1,117.1 points. Liquidity decreased slightly with 571.6 million shares matched on HOSE.

VN30 group was also cautious in the afternoon session but the green color remained throughout the session and increased by 0.78%. Up to 20 gainers like MWG (+4%), GAS (+3.5%), GVR (+3.4%), VIC (+3.1%), BVH (+2.2). % ... On the other side, PDR (-3.2%), BID (-3%), CTG (-2.4%), VNM (-1.6%), SSI (-1.2%) were the notable losers.

With the prolonged uptrend of the market, many industry groups still remained in the green color, the number of gainers still dominated. Significantly, Oil & Gas, Mining, followed by Steel, Chemicals, Retail... By contrast, Brokerages group could not keep the green and dropped at the end of the session.

Foreign investors continued to be net buyers on HOSE with the value of VND 518.9 billion. They net bought a lot at HPG (+174.1 billion), VIC (+91.4 billion), HCM (+65.1 billion), FRT (+35.2 billion), SSI (+32.2 billion)... Conversely, VNM (-67.7 billion), CTG (-37 billion), VCB (-36.8 billion), DGC (-36.7 billion), STB (-28.4 billion) were net sold the most.

The market's gaining momentum lingered in the first session of the Year of Rabbit. However, the uptrend somewhat slowed down before the profit-taking supply, as shown by the Shooting Star candle. Market still remained in green at the end of the session, showing that the pressure of supply is not great. It is expected that the market will temporarily step back in the next session to find a balance after the recent rise. Therefore, investors should slow down and observe the cash flow to support the market in the near future. However, it is possible to wait for good price accumulation in stocks with an active accumulation background.

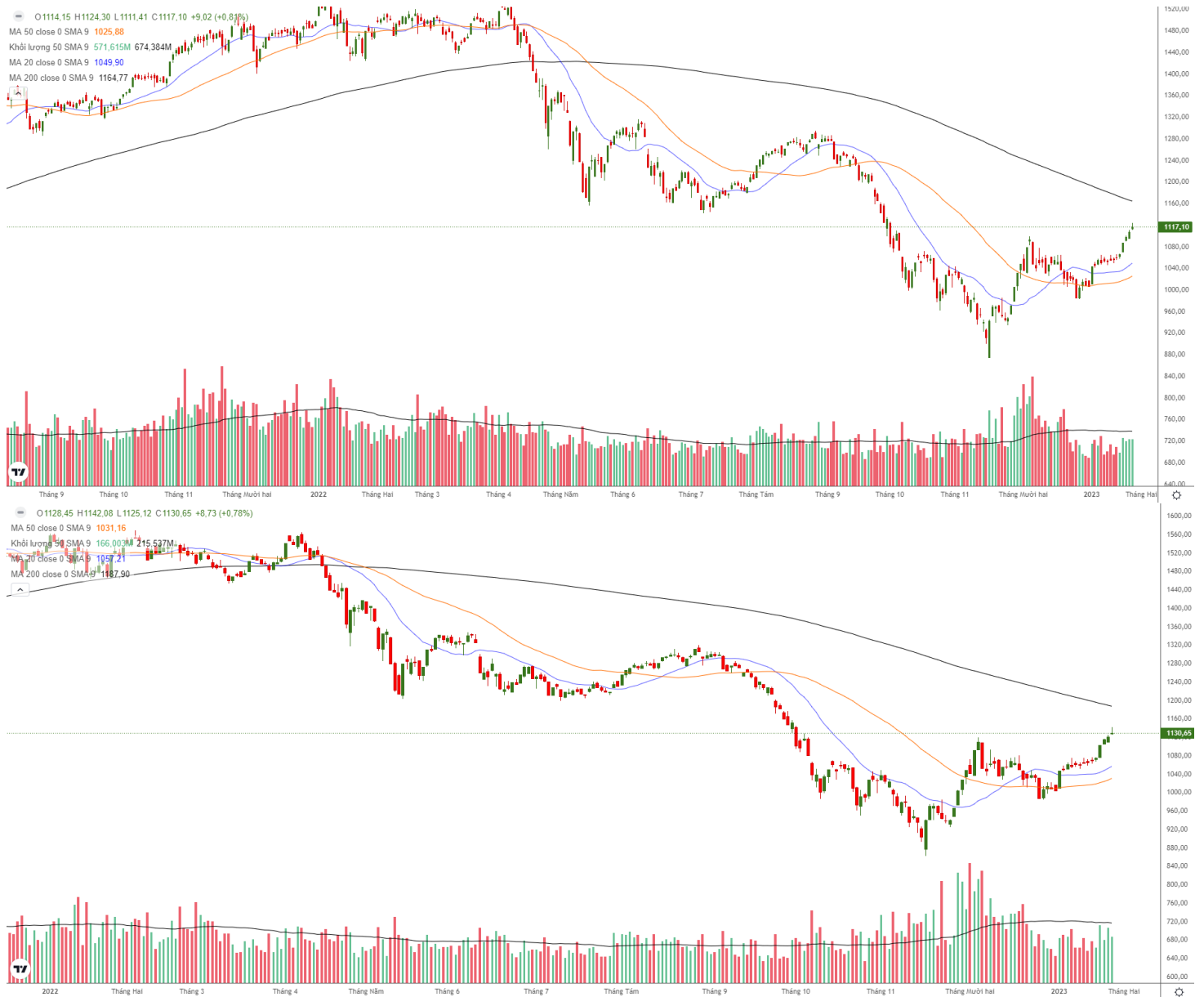
