“Efforts to maintain 1,250 point mark”

Market today: Efforts to maintain the 1,250 point mark

- *The market fell and tested the support candle signal again on September 11.*
- *Efforts to maintain the score above the 1,250-point threshold also create a supporting factor for market recovery expectations.*

With the cautious movement of cash flow, the market entered the last trading session of the week in red. Although the decrease in points during the session was not too large with the support movement around 1,250 points, the market performance was quiet with a narrow fluctuation range. VN-Index decreased by 4.64 points (-0.37%), closing at 1,251.71 points. Matching liquidity remained low with 383.6 million shares matched on HOSE.

VN30-Index decreased by 3.31 points (-0.26%), closing at 1,294.3 points. In the group, there were 10 gainers such as VRE (+1.6%), SAB (+1.3%), SSB (+1.3%), PLX (+0.9%), HDB (+0.8%) ... On the contrary, there were 18 losers, namely VNM (-2.4%), GAS (-2.4%), MSN (-1.2%), VIB (-0.8%), POW (-0.8%)....

With the market's sluggish performance, the red color was still dominated the market, but there was a differentiation between stock groups. Technology, Securities, Real Estate, etc. were the groups that were making efforts to increase prices.

Foreign investors continued to be net sellers on HOSE, with a value of 73 billion VND. They sold heavily at VHM (-189.2 billion), MWG (-124.3 billion), VCI (-85.5 billion), HPG (-73.4 billion), HSG (-36.8 billion) ... However, they bought strongly at FPT (+195.2 billion), STB (+83.2 billion), DXG (+56.1 billion), FTS (+40.8 billion), TPB (+38.9 billion)...

The market decreased and tested the support candle signal again on September 11. Liquidity remained low, showing that the support cash flow was still limited, but the supply did not cause much pressure when the market decreased. It is expected that the market will continue to test supply and demand in the next trading session. However, the effort to maintain the score above the 1,250 point threshold also creates a supporting factor for the market's recovery expectation. Therefore, investors need to observe the supply and demand developments in the support zone, and should prioritize stocks that have had stable developments and attracted cash flow recently. However, it is still necessary to temporarily consider the recovery phase to close short-term profits or restructure the portfolio to minimize risks.

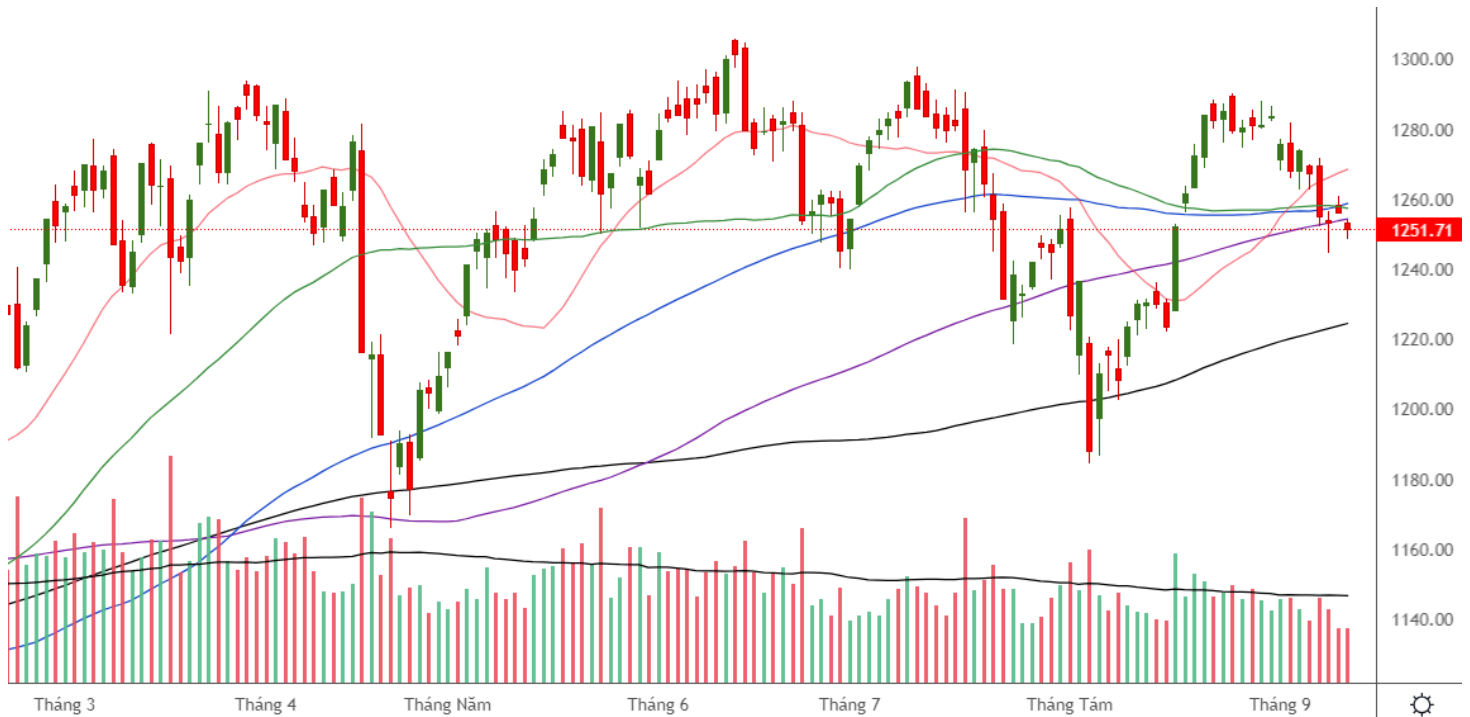
