Market today: Slowed down gaining momentum

- The market continued to gain, but somewhat cooled down after a series of gaining sessions.
- However, the decline is still limited, so the market still has a chance to gain in the next session. However, it is likely that the market will only fluctuate to explore the supply at the resistance zone of 1,080 - 1,100 points of VN-Index in the near future.

With the acceleration at the end of the previous session, the market continued to enter a new session in green. However, the gaining momentum quickly cooled down and caused the indexes to struggle below reference. In the end, VN-Index decreased slightly by 0.83 points (-0.08%) and closed at 1,078.45 points. Liquidity decreased slightly compared to yesterday, with 746.2 million shares matched on HOSE.

Disputes around the reference also occurred in the VN30 group. In the end, VN30 closed with a decrease of 0.38 points (-0.03%). The breadth was in the bearish group with 16 losers including VHM (-3%), VIC (-2.1%), BCM (-1.8%), SAB (-1.7%), CTG (-1%)... On the other side, there were 13 gainers like POW (+2.3%), SSI (+2.3%), MSN (+2.1%), MWG (+2.1%), VIB (+1.8%)...

Although the market's gaining momentum slowed down and the supply pressure somewhat put pressure on many groups today, the majority of sectors remained in green. Prominent were Securities, Agriculture - Forestry - Fisheries, Retail, Wholesale... Meanwhile, stocks in some large groups such as Banking and Real Estate had alternative ups and downs.

Foreign investors continued to be net sellers on HOSE, with a value of VND 268.5 billion. They sold a lot at STB (-104 billion), VNM (-56.6 billion), FUEVFVND (-44.3 billion), VND (-41.7 billion), SSI (-29.5 billion)... By contrast, they bought the most at VPB (+44.1 billion), VIC (+36.4 billion), KBC (+30.4 billion), HCM (+19.9 billion), HPG (+14.5 billion)...

The market continued to gain, but cooled down after a series of gaining sessions. Selling pressure was active again in today's session, reflected in the recent state of struggling on a high base of liquidity. However, the decline is still limited, so the market still has a chance to gain in the next session. However, it is likely that the market will only fluctuate to explore the supply at the resistance zone of 1,080 - 1,100 points of VN-Index in the near future. Therefore, investors should slow down and observe the supply and demand movement at the resistance zone. Temporarily, it is advisable to avoid overbought status and take advantage of the market's rally to take short-term profits and minimize risks for the portfolio.

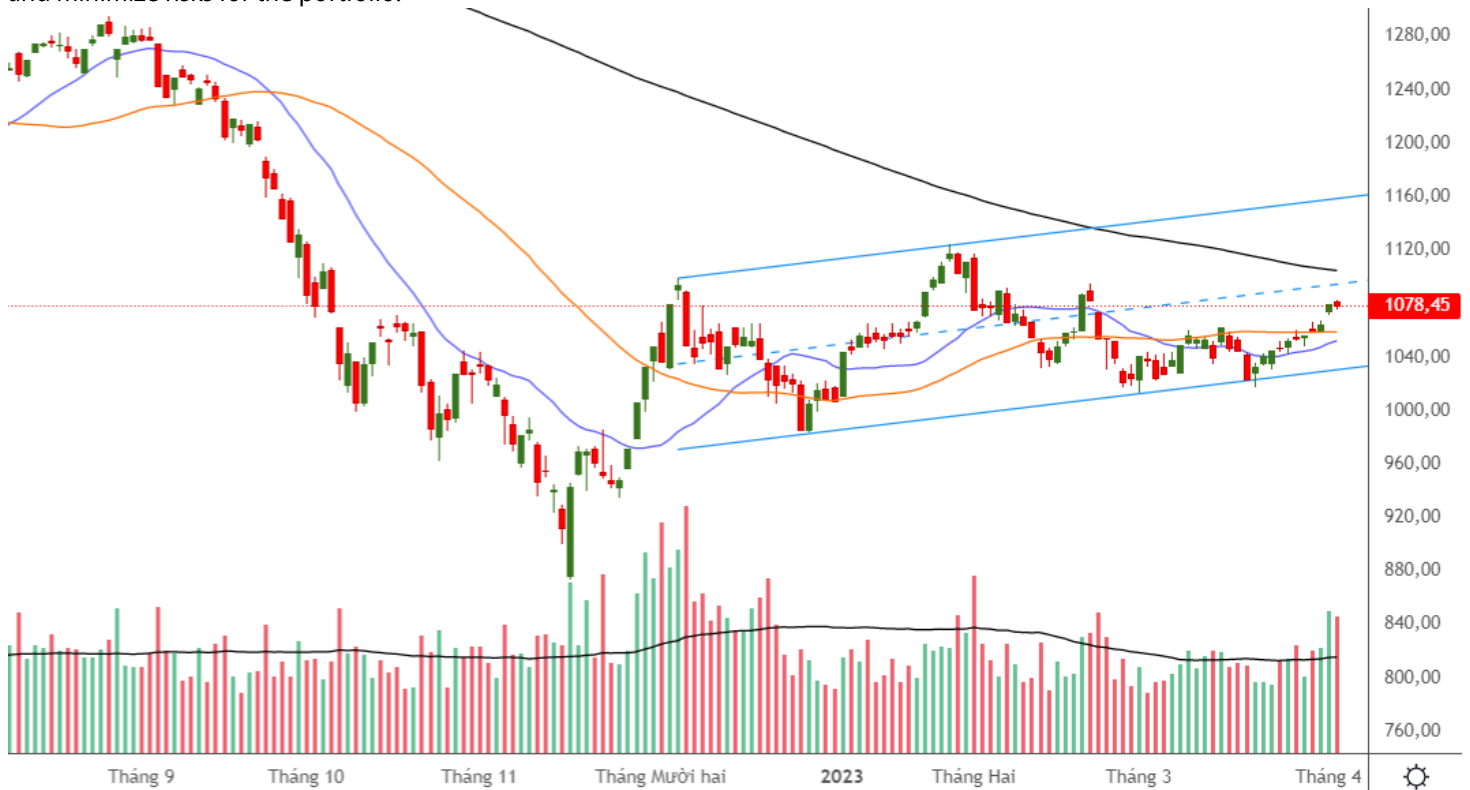

However, the decline is still quite low, so it is likely that the market will continue to explore the supply at the resistance zone of 1,080 - 1,100 points of the VN-Index in the near future. Therefore, investors should slow down and observe the supply and demand movements at the resistance zone. Temporarily should avoid overbought status and take advantage of the market's uptrend to take short-term profits and minimize risks for the portfolio.

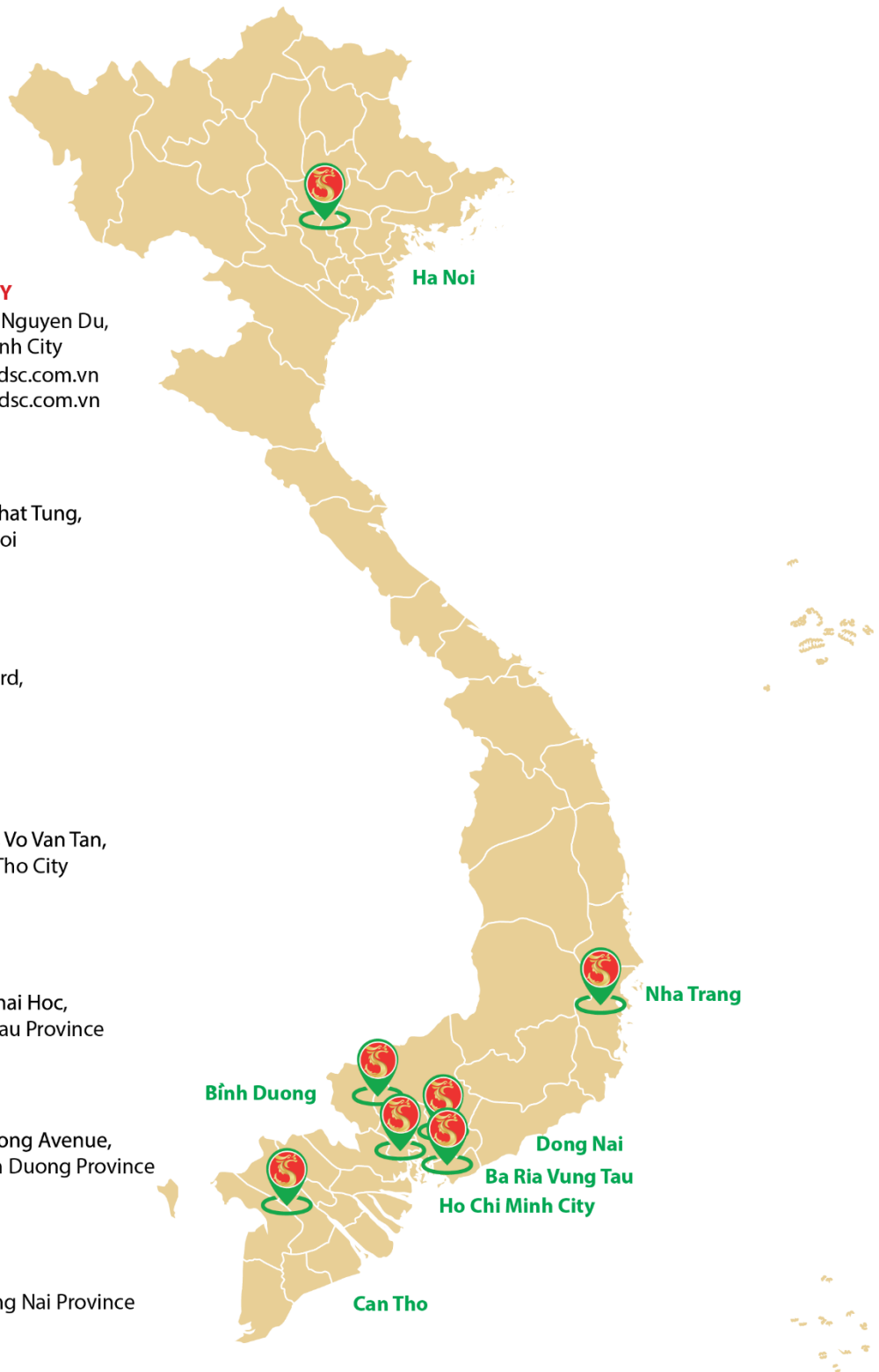
