

Market today: Recovery

- The market's decline has stopped and has recovered thanks to the support of the MA(200).
- It is possible that the recovery will continue in the next trading session, but the development may be difficult, especially with the resistance pressure of the 1,140 area.

Continuing the downward momentum from the previous session, the market entered the new trading session in the red. However, the decline was quickly contained as the VN index retreated to nearly 1,105 points and the market gradually recovered. After a period of hesitation above the reference level, the recovery range widened towards the end of the session. VN index rose by 10.57 points (+0.95%) to close at 1,128.67 points. Matching liquidity decreased with 646.1 million shares matched on HOSE.

The VN30 group increased by 7.65 points (+0.68%) and closed at 1,138.54 points. In the group, SSI (+5.1%), VIC (+3.6%), STB (+3.4%), VRE (+2.7%), GVR (+2.6%)... managed to rise. Conversely, only losers were SSB (-1.8%), VJC (-1.1%), TCB (-0.8%), MSN (-0.7%), CTG (-0.7%) ...

With the market's reversal and recovery, there are many stock groups that have regained the green color after the recent price drop, and the number of gainers also outnumbered. The highlight is the recovery move of the Securities group, which has contributed to supporting investor psychology and helping the green color to spread. Next, Chemical, Oil & Gas, Steel, Retail group... also had quite good recovery.

Foreign investors returned to net buying on HOSE with a value of VND189.6 billion. In particular, they bought a lot in DGC (+69 billion), SSI (+55.2 billion), VND (+43.6 billion), VIC (+43 billion), VIX (+33.1 billion)... In the afternoon, they sold heavily in CTG (-46.3 billion), DPM (-43 billion), MSN (-36 billion), MWG (-34.5 billion), FUEVFVND (-22.4 billion)...

The market's decline stopped and recovered thanks to the support of the MA(200) area in the VN index. The recovery was maintained quite well thanks to the temporary cooling of supply pressure after a strong selling session, but in general, the support flow was still not drastic, which is reflected in the low liquidity. It is possible that the rally will continue in the next trading session, but the development may be difficult, especially with resistance pressure at the 1,140 level. Therefore, investors need to monitor and evaluate supply and demand as the market recovers. It is still necessary to consider the market's ability to recover in order to restructure the portfolio in a way that minimizes risk.

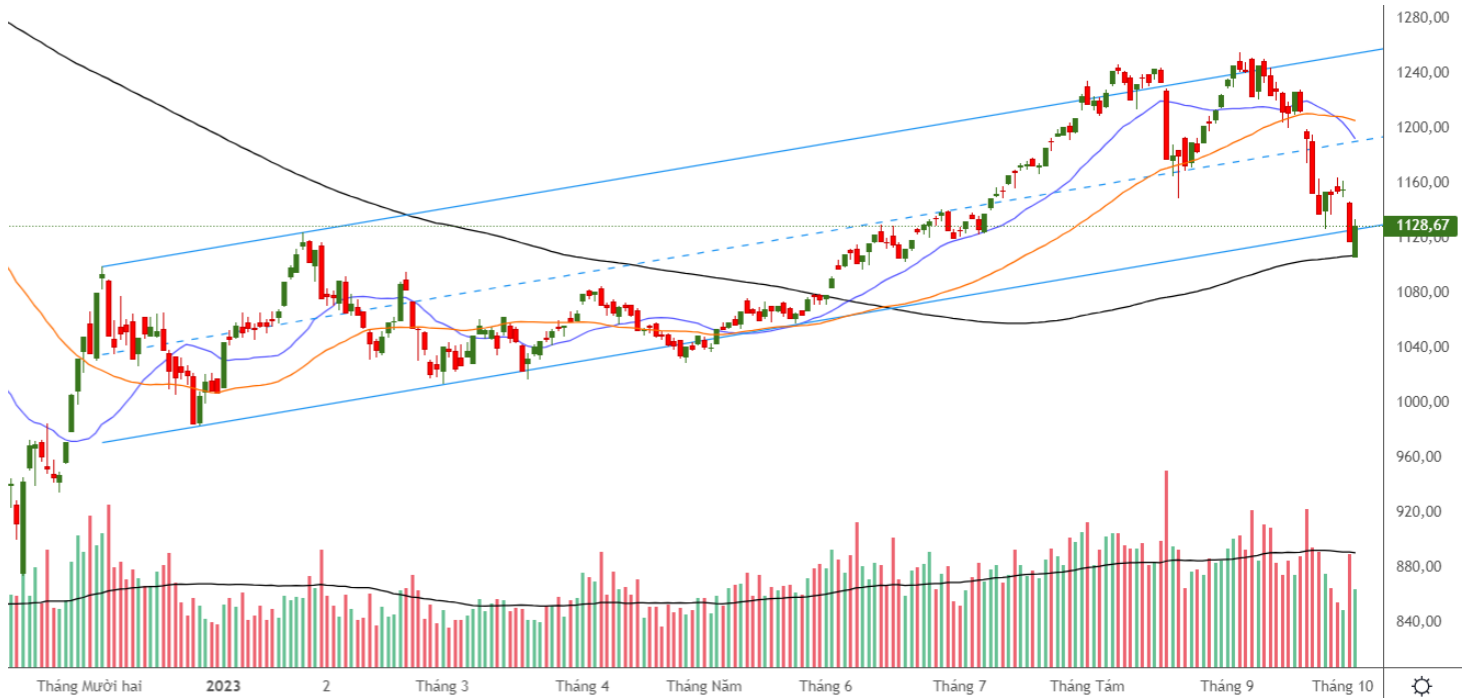

It is possible that the recovery will continue in the next trading session, but developments may be difficult, especially with the resistance pressure of the 1,140 point area. Therefore, investors need to observe and evaluate supply and demand when the market recovers. Temporarily, it is still necessary to consider the market's recovery ability to restructure the portfolio in a way that minimizes risks.

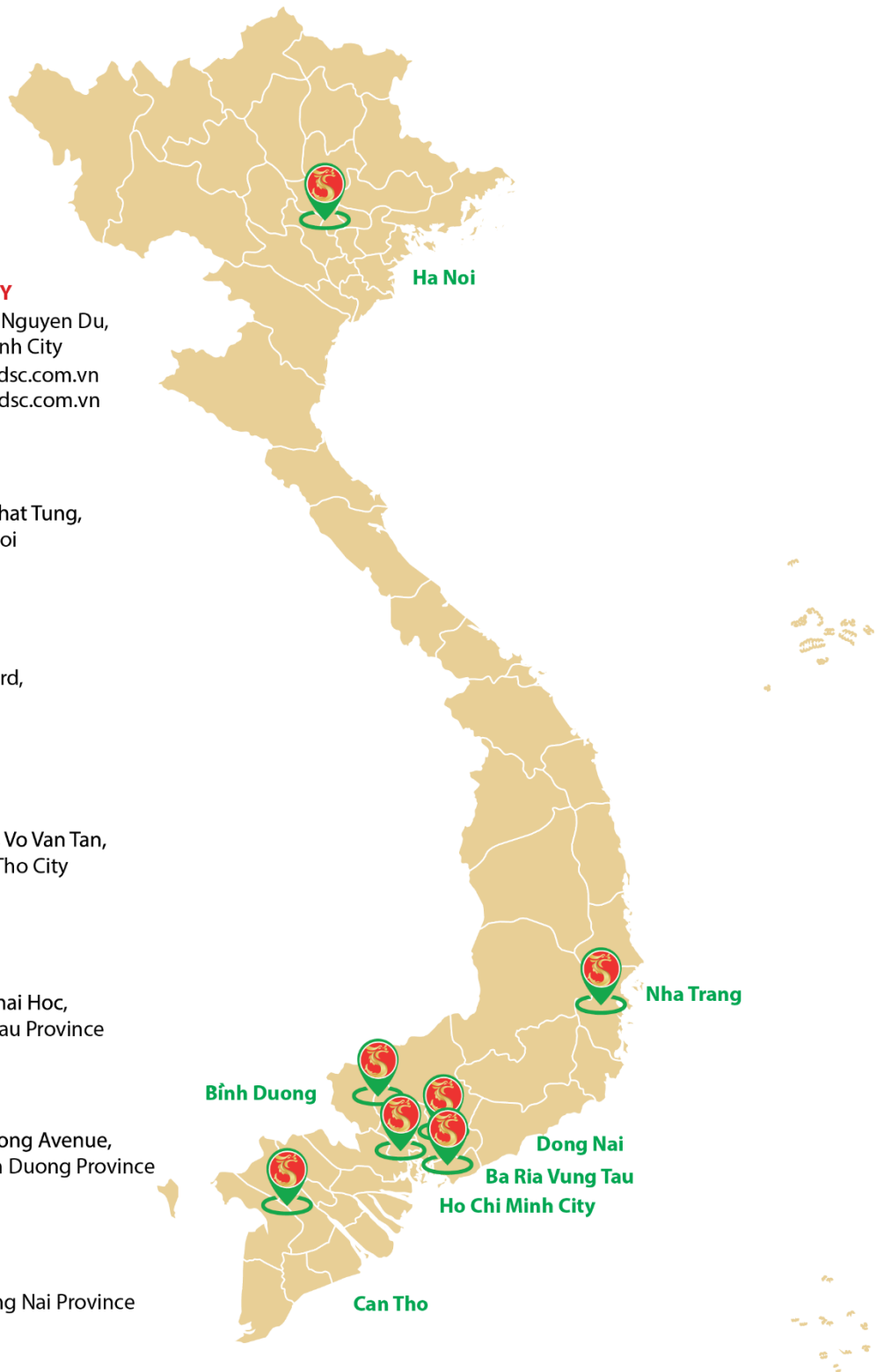
