Market today: Extending increasing momentum

- The market continues to maintain its upward momentum despite profit-taking pressure during the session.
- With signals surpassing profit-taking pressure, the market has the opportunity to break through the resistance level of 1,277 points and expand its recovery momentum in the near future.

The market continued its bullish trend as it entered the weekend trading session. However, the upward movement faced challenges as the market pushed above the 1,270-point level, with the state of struggle dominating this session. A positive point is that the market continued to show support towards the end of the session. VN-Index gained 4.33 points (+0.34%), closing at 1,273.11 points. Trading volume increased with 830.8 million shares matched on the HOSE exchange.

VN30-Index rose by 1.88 points (+0.14%), closing at 1,310.15 points. In the group, there were 14 gainers such as MSN (+4.3%), GVR (+2.5%), VRE (+2%), VHM (+1.5%), SHB (+1.3%)... Conversely, there were 12 losers, namely VCB (-0.9%), FPT (-0.7%), PLX (-0.7%), MBB (-0.6%), BID (-0.5%).

With efforts to maintain the market's upward momentum, many industry groups still retained their bullishness despite differentiation in the market. The highlight is Consumer Goods group, which continuously supported the market throughout the trading session. Additionally, Chemicals group, Securities group, and Transportation - Warehouse groups also showed lively movements.

Foreign investors returned to be net sellers on HOSE, with a value of 794.6 billion VND. In particular, they sold strongly at VHM (-148.2 billion), VNM (-72.8 billion), FPT (-66.2 billion), MWG (-58.2 billion), CMG (-56.1 billion) ... However, they bought a lot at DBC (+47.5 billion), FUEVFVND (+45.1 billion), HAG (+42.5 billion), NLG (+38.6 billion), DGW (+ 37.5 billion).....

The market continues to maintain its upward momentum despite profit-taking pressure during the session. Trading volume increased compared to the previous session, indicating an increase in profit-taking activity, however, the cash flow is still supportive and absorbing the supply. With signals surpassing profit-taking pressure, the market has the opportunity to break through the resistance level of 1,277 points and expand its recovery momentum in the near future. However, the supply, as well as liquidity, are likely to increase and create contention as the market reaches new highs, especially in the challenging range of 1,280 - 1,300 points. Therefore, investors may consider gradually expanding their market recovery momentum, but should still note that the supply is likely to increase and create contention in the near future. Currently, it may be preferable to hold or short-term buy stocks with good signals from support levels.

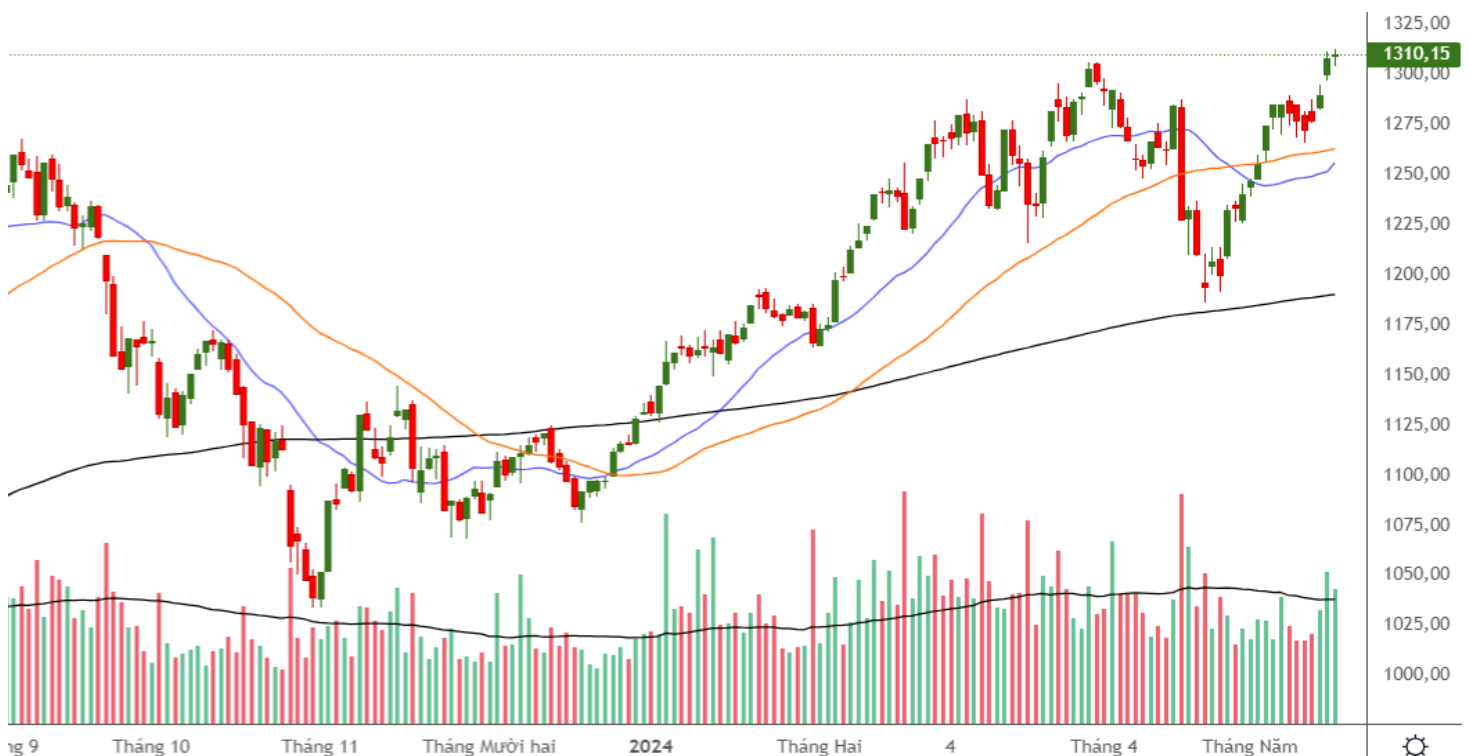
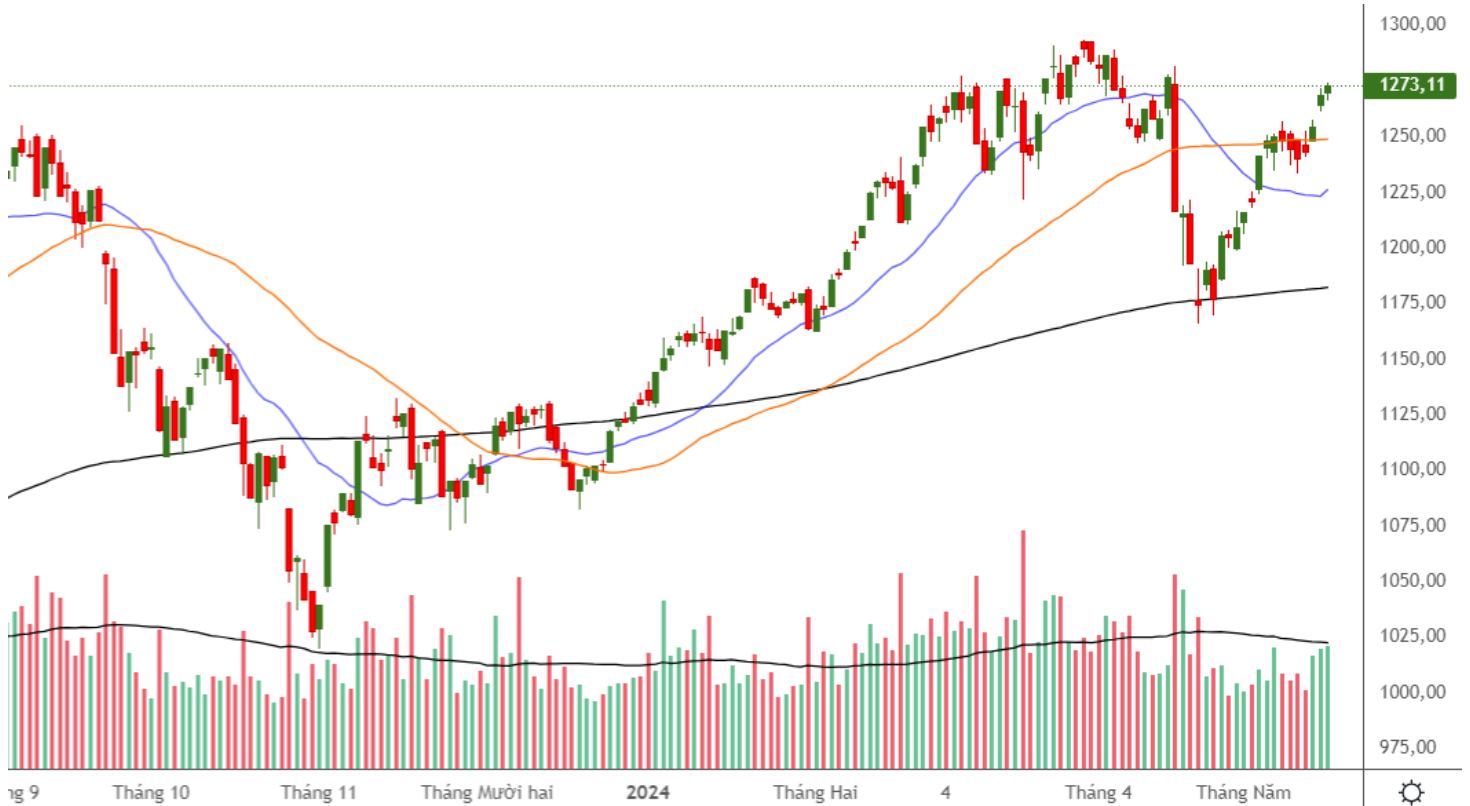

However, supply will tend to increase and cause disputes when the market records new highs, especially in the challenging area of 1,280 - 1,300 points. Therefore, investors can expect the possibility of gradually expanding the market's recovery, but it is still necessary to note that supply will tend to increase and cause disputes in the near future. Currently, investors can prioritize holding or short-term buying in stocks that have good signals from the support area.
