**Market today: Market cooled down**

- The current cooling signal may exert pressure to retreat in the next trading session.
- It is expected that the market will receive support at the 1,255 point level and recover due to the impact of the previous session's crossing above the MA(200) line.

Market continues to maintain a green color as it enters a new trading session. However, it quickly cooled down from the 1,267 point threshold and showed hesitation around the reference mark for most of the trading session. After several unsuccessful attempts to break through the resistance, the market gradually retreated into the red zone by the end of the trading session. VN-Index decreased by 1.53 points (-0.12%), closing at 1,259.75 points. Liquidity declined with 470.4 million shares traded on HOSE.

VN30-Index dropped by 2.91 points (-0.22%), closing at 1,326.65 points. Within this group, only five stocks increased in value, namely FPT (+0.4%), PLX (+0.4%), STB (+0.3%), VCB (+0.3%), and VNM (+0.2%). In contrast, 20 stocks closed in the red, such as MSN (-1.2%), GVR (-1.2%), TPB (-0.9%), BID (-0.9%), and VPB (-0.8%).

With the market cooling down, some stock groups slightly retreated, showing a mixed performance across the market. The Technology, Real Estate, and Transportation – Warehousing sectors were among those that were active and had a supportive impact on the market.

Foreign investors continued to sell off on the HOSE exchange, with a net value of 390.9 billion VND. They heavily sold VHM (-103.8 billion), MSN (-85.6 billion), CMG (-67.4 billion), VCB (-47.7 billion), and KBC (-41.4 billion). Conversely, they bought significantly in MWG (+47.6 billion), STB (+42.9 billion), TCB (+40.7 billion), DXG (+30.7 billion), and VND (+29.7 billion).

*The market continues to face pressure from the 1,267 point area, which is also the MA(20) zone, leading to a cooling off. Liquidity decreased compared to the previous session, indicating that the selling pressure is not yet significant, but capital flows remain cautious as the market approaches the resistance zone. The current cooling signal may exert pressure to retreat in the next trading session. However, it is anticipated that the market will receive support at the 1,255 point level and recover due to the impact of the previous session's crossing above the MA(200) line. The supply-demand dynamics in the exploratory range of 1,255 – 1,267 points will influence the market's next moves. If it continues to receive support, there is still an opportunity for the market to return to the 1,300 point level. Therefore, investors need to observe the efforts of capital flows in the coming period. Currently, it may be considered to cautiously buy stocks showing strong capital flow signals from the support level, but also to consider short-term profit-taking on some stocks that have rapidly increased towards the resistance area.*

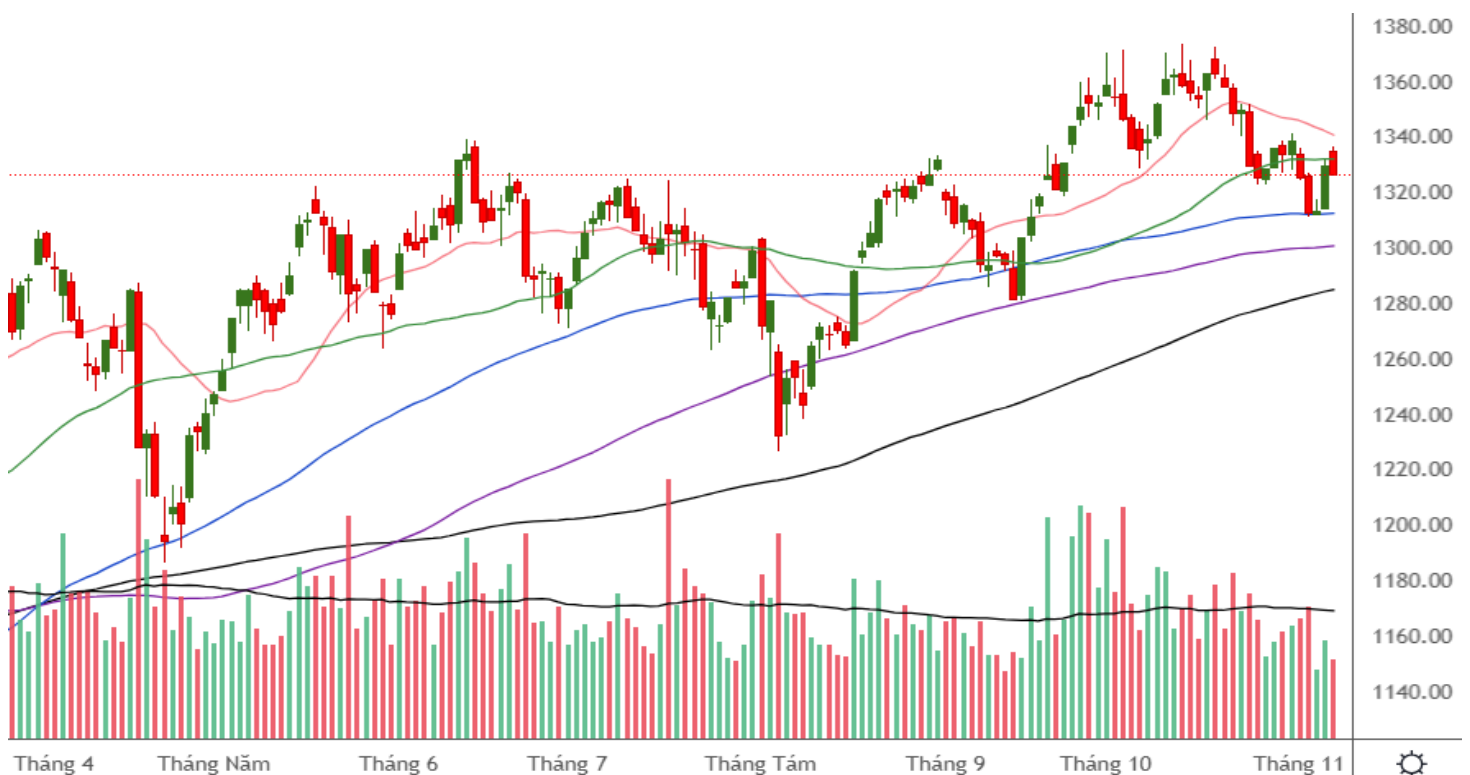
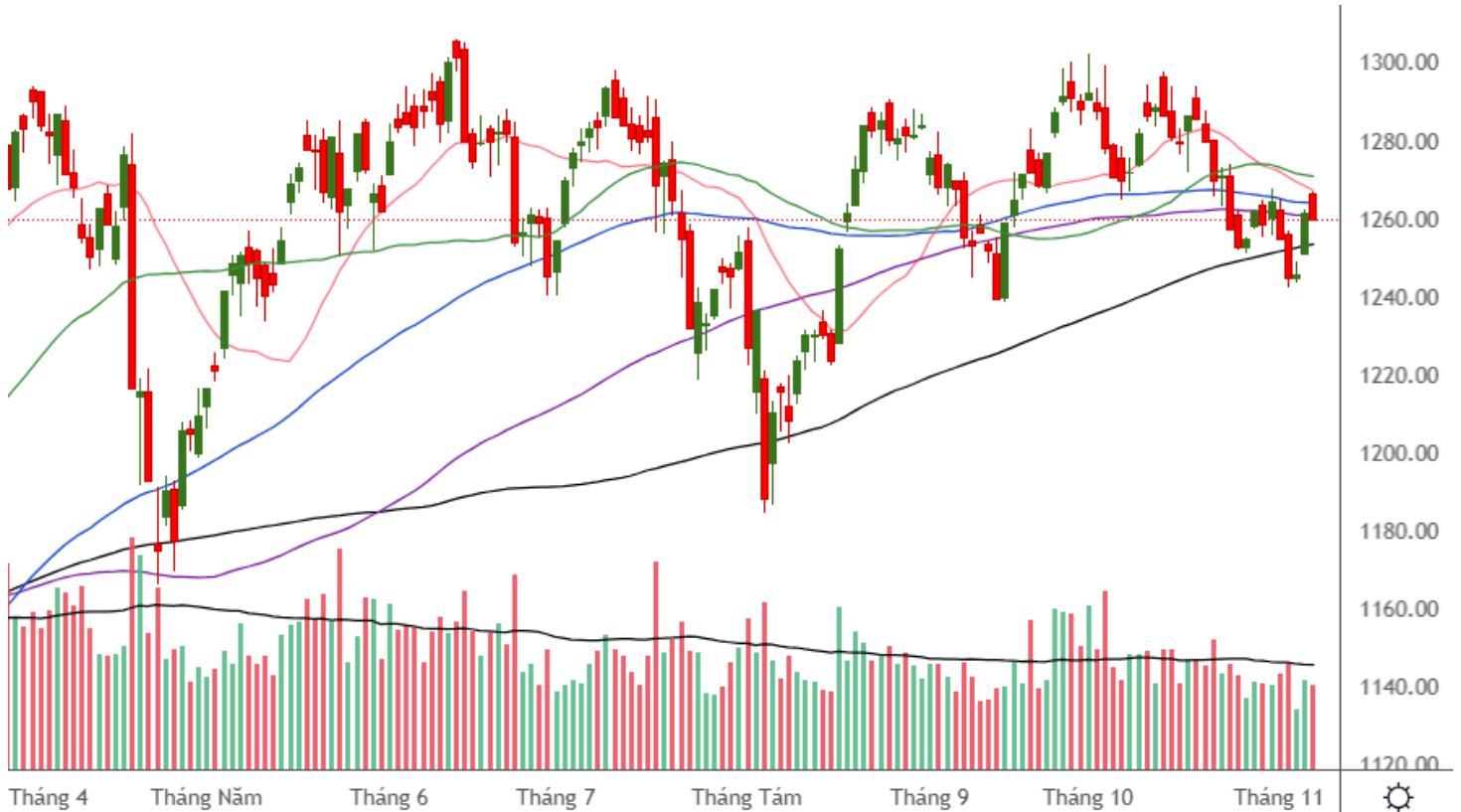

**“Market cooled down”**

**Technical Analyst Recommendations**

The market was resisted at the 1,267 points area, also the MA(20) area, and cooled down. This signal may cause pressure to retreat in the next trading session. However, it is expected that the market will be supported at the 1,255 point area and recover thanks to the signal of surpassing the MA(200) in the previous session. The supply and demand signals in this area will have an impact on the next move of the market. Therefore, investors need to observe cash flow efforts in the near future. Currently, investors can consider buying probingly in stocks with good cash flow signals from the support level, but also need to consider short-term profit taking for some stocks that have increased rapidly to the resistance area.
