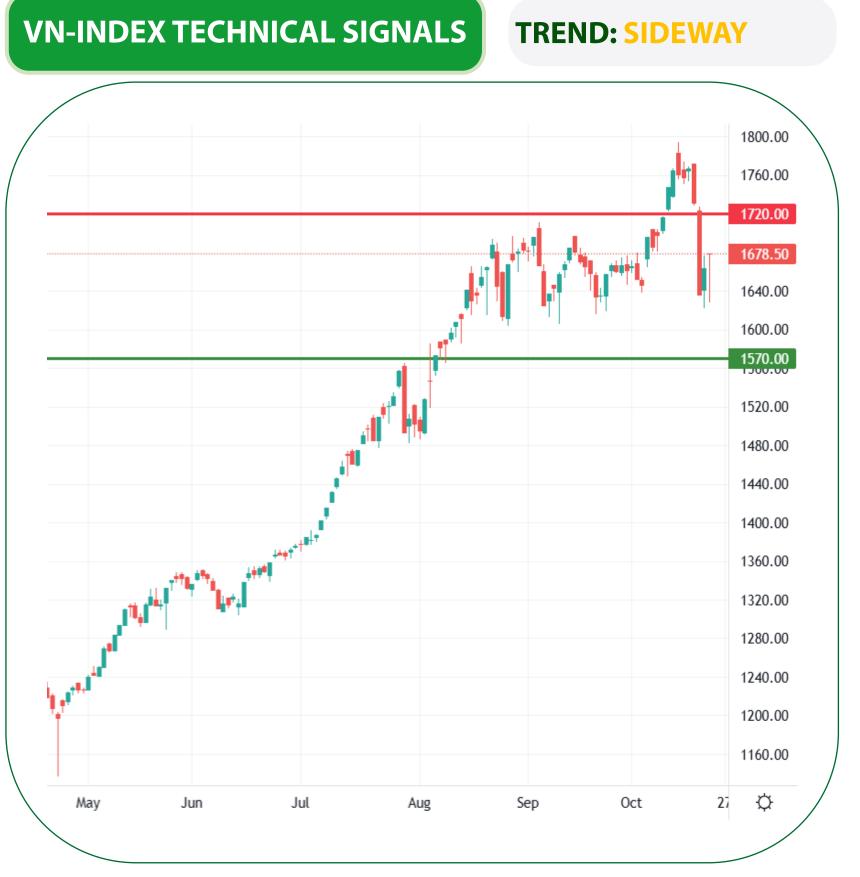
MARKET AND TRADING STRATEGY

MARKET COMMENTARY

- ➤ The market continues to register a support signal as it pulled back to the 1,625 1,630 point area and recovered, while also climbing above the MA(50) line, at 1,672 points. Liquidity decreased compared to the previous session, indicating that selling pressure has temporarily cooled down after the sharp sell-off in recent sessions.
- ➤ With the current support and recovery signal, the market's potential for recovery may continue in the next trading session. The objective of this recovery phase is to retest the 1,700 1,720 point area, the support zone that the market lost on October 20, 2025.
- > Trading signals at this resistance area may have a significant impact on the market's next move.

TRADING STRATEGY

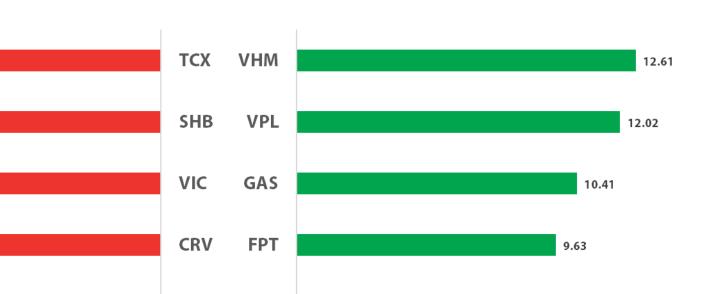
- Investors temporarily still need to be cautious of the market's short-term risk factors and observe the supply and demand dynamics at the resistance area to evaluate the market condition.
- Investors may consider recovery swings in the near future to take profits or restructure their portfolio towards risk mitigation.
- ➤ On the buying side, if the portfolio proportion is at a reasonable level, Investors may consider making trial purchases in some stocks that have a good upward price pattern.



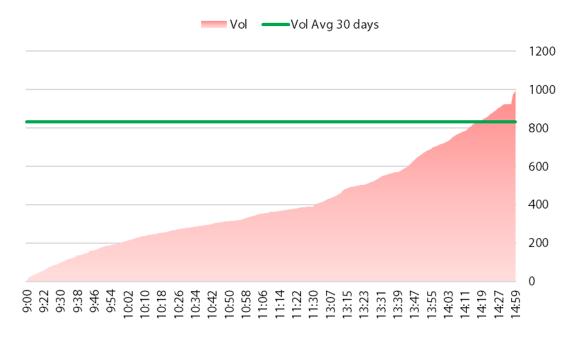

TOP SECTOR CONTRIBUTING TO THE INDEX (%)

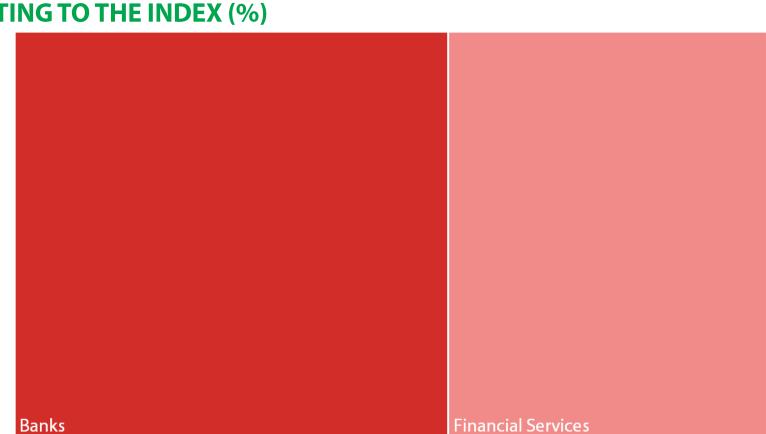

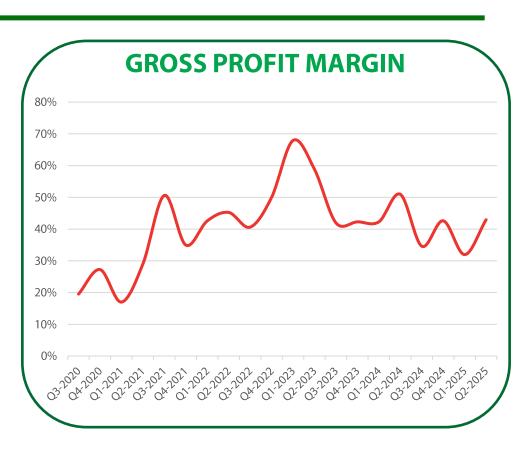
INVESTMENT THESIS

- In the second quarter of 2025, NLG recorded revenue of 773 billion VND, a decrease of 40% quarter-on-quarter but a strong growth of 207% year-on-year. Net profit after tax attributable to parent company shareholders reached 99 billion VND, down 8% quarter-on-quarter but up 168% year-on-year. In the first six months of 2025, the company's net revenue reached 2,064 billion VND (up 352% year-on-year) and net profit after tax for parent company shareholders was 208 billion VND (up 209% year-on-year). Inventory at the end of the second quarter increased slightly to 17,901 billion VND, indicating that the company is boosting construction investment.
- The second quarter's revenue was mainly driven by the handover of the Akari 2 and Nam Long Can Tho projects. The quarter-on-quarter revenue decrease was due to the majority of handovers being concentrated in late 2024 and the first quarter of 2025. However, the gross profit margin remained high at 43%, thanks to a higher proportion of high-rise product handovers and well-controlled selling and administrative expenses. The biggest bright spot of the quarter was the surge in presales to 2,789 billion VND, mainly from the Southgate project, signaling a positive recovery in the satellite real estate market.
- The company is pursuing a smart strategy by proactively boosting sales in the second half of 2025 with projects like The Pearl, Izumi, and Mizuki to capitalize on the market's recovery momentum. We forecast that the business results for Q3 will be very positive, with estimated revenue of 1,186 billion VND (+220% year-on-year) and net profit after tax for parent company shareholders of about 529 billion VND (+34% year-on-year), mainly thanks to handovers at the Waterpoint project and a capital transfer deal at the Izumi project

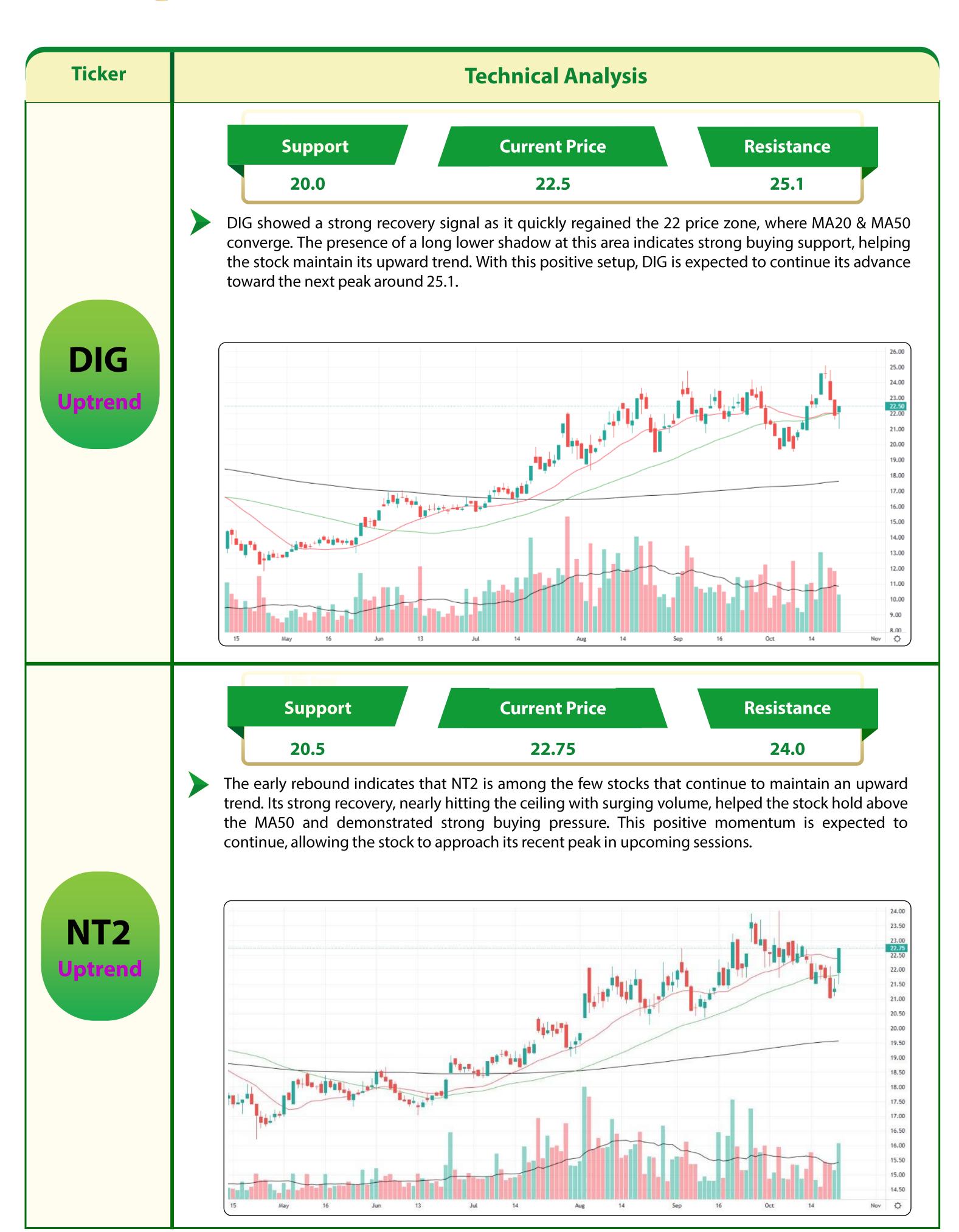
TECHNICAL VIEW

• Although price volatility was quite strong and there were times when it fell into an oversold condition recently, overall, NLG still maintained the 36 support area by forming an accumulation base. Concurrently, liquidity has also shifted positively recently, demonstrating investor interest. Therefore, it can be expected that the correction phase since mid-August 2025 is showing signs of ending. It is anticipated that NLG will continue to receive support from the 36 - 37 area and gradually turn toward an upward price trend in the near future.

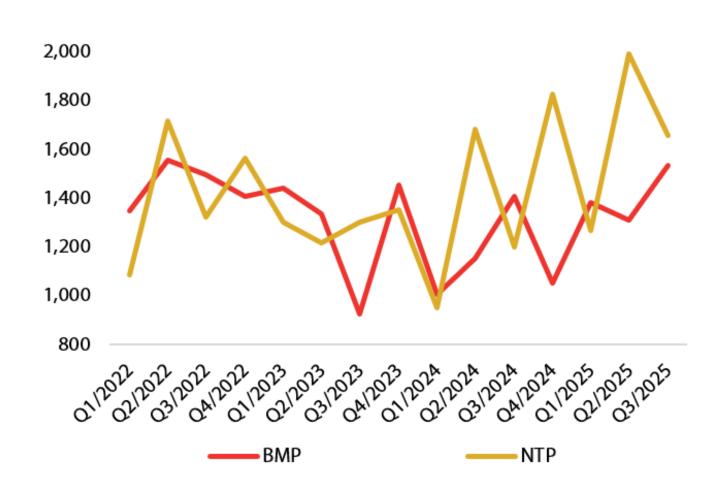
HIGHLIGHT POINTS

BMP and NTP: Q3-2025 Business Results Update

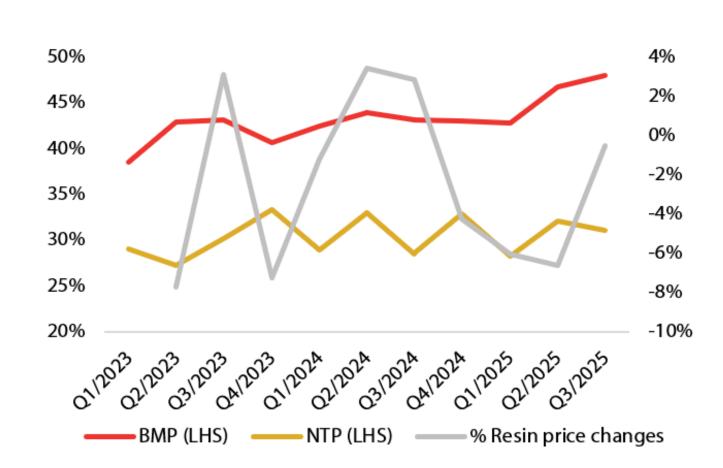
- Revenue: Revenue of BMP and NTP reached 1.532 trillion VND (+9% YoY; +17% QoQ) and 1.609 trillion VND (+34% YoY; -19% QoQ), respectively, both at high levels for the period from 2019 to 2025. BMP's positive revenue growth compared to NTP is mainly supported by the southern consumption market (BMP's main market) recovering better than the northern market (NTP's main market) due to the impact of storms and rains.
- Gross profit: BMP and NTP's gross profits remained high thanks to low plastic resin costs, reaching 734 billion VND (+21% YoY, +48% QoQ) and 500 billion VND (+46% YoY, -22% QoQ), respectively.
- **Discount policy:** BMP significantly increased sales discounts, while NTP showed no significant changes.
- Net profit: BMP and NTP recorded historically high net profits, reaching 350 billion VND (+21% YoY; +6.3% QoQ) and 257 billion VND (+18.5% YoY; -19.6% QoQ), respectively.
- **Financial structure**: In general, the financial structure of both BMP and NTP is strong, with high cash reserves and low debt-to-equity ratios.

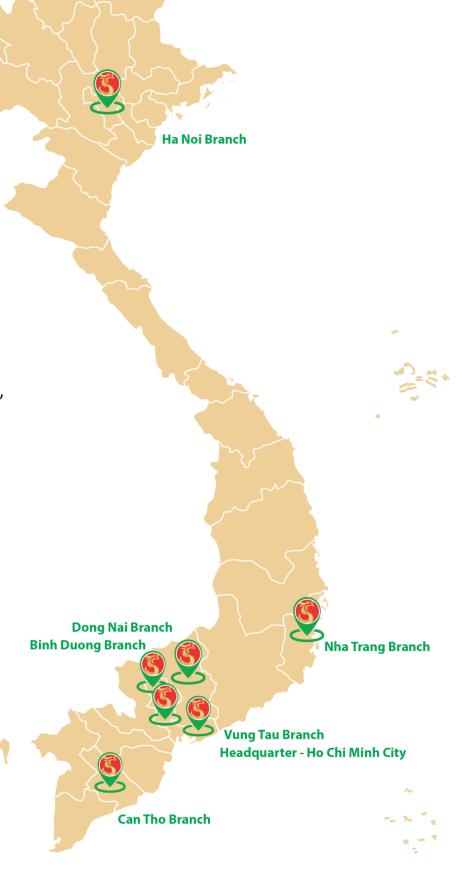
