

“Caution movement”

Market today: Caution movement

(Phuong Nguyen – phuong.nh@vdsc.com.vn)

- Throughout the session, cautiousness and exploratory retardation predominated.
- It is likely that the market will retest the support area of 1,030 points in the next session. The market's downtrend may pause at this zone, but the market's risks are increasing, so it is necessary to consider the possibility that the support of this zone may decrease.

Although there was a quick recovery from the previous session, market still returned to a cautious state when entering the last session of the week. The state of exploration was clearly shown when the liquidity remained at a low level throughout the morning session. Liquidity in the afternoon session improved but the market's movements continued to weaken. VN-Index dropped 14.1 points (-1.34%) and closed at 1,039.56 points. Liquidity decreased with 404.2 million shares matched on HOSE.

VN30 group also stepped back with a decrease of 1.95%. Only SAB (+1%), GAS (+0.7%), and VCB (+0.2%) managed to rise. By contrast, 26 decliners like SSI (-3.6%), NVL (-3.4%), GVR (-3.4%), HPG (-3.3%), PDR (-3.2%)...

With the rather poor performance of the market, most of the major industry groups were in the red and losers dominated the whole market. Oil & Gas group lost its positive status and turned down at the end of the session. In addition, there are many industry groups that have negative impacts on the market such as Steel, Securities, Real Estate...

Foreign investors continued to be net sellers on HOSE with the value of VND 219.2 billion. They sold a lot at VHM (-43.2 billion), VIC (-36.6 billion), DGC (-30.5 billion), DCM (-22.6 billion), VNM (-18.3 billion)... On the other hand, they bought a lot at VCB (+23.1 billion), STB (+21.6 billion), PC1 (+12.5 billion), NKG (+8.8 billion), DPM (+8.2 billion). ...

The quick recovery from the end of the previous session did not help the market to prosper. Cautiousness and exploratory retreat remained dominant in the session. Although the volume was low, selling pressure almost dominated the whole session, as shown by the closing price stopping close to the lowest level of the day. With this development, it is likely that the market will retest the support area of 1,030 points in the next session. The market's downtrend may pause at this zone, but the market's risks are increasing, so it is necessary to consider the possibility that the support of this zone may decrease. Therefore, investors should be cautious and observe the balance of supply and demand at the support zone of the market. In addition, it is advisable to maintain the portfolio weight at a reasonable level and take advantage of the market's retracements to structure the portfolio in the direction of minimizing risk.

Technical Analyst Recommendations

After a quick recovery from the support area of 1,030 points, the market still remained cautious and stepped back to explore the support zone of 1,030-1.045. Although the volume was low, selling pressure dominated the whole session, as shown by the closing price stopping close to the lowest level of the day. With this development, it is likely that the market will continue to probe 1,030 points to find support signals of money flow in the next session. At the same time, the risk of returning to the downtrend afterwards is also high. Therefore, investors should pay attention to observe the supply-demand balance, temporarily take advantage of the market's recovery to take profits or restructure the portfolio in the direction of minimizing risks.

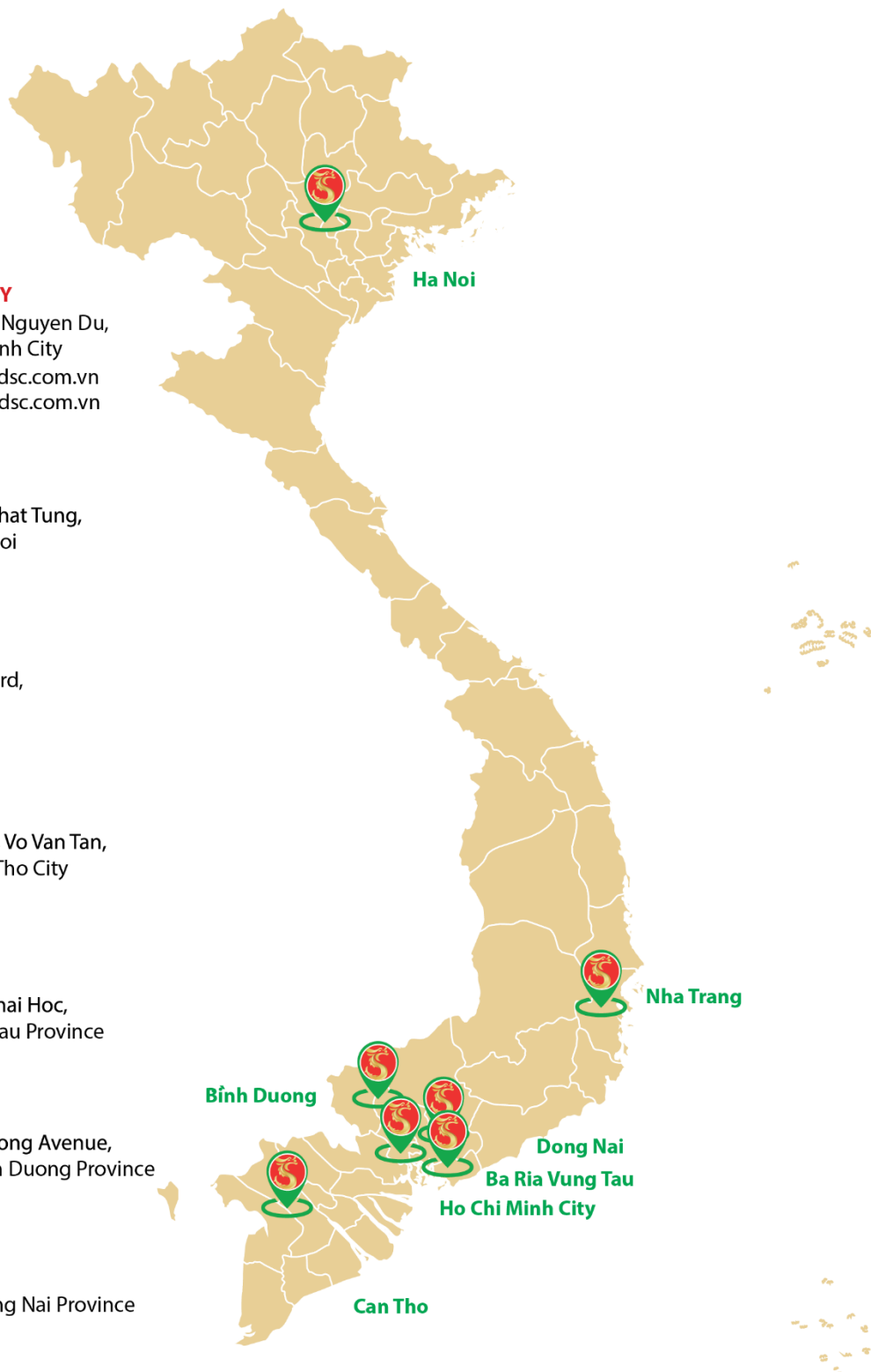
