# "Hesitation"

## **Market today: Hesitation**

(Phuong Nguyen - phuong.nh@vdsc.com.vn)

- The market hesitated near the 1,210-point level after a strong rebound session.
- The tug-of-war around the 1,210-point area may continue in the next trading session before clearer signals emerge.

The market maintained its upward trend at the beginning of the trading session. However, the point gain was limited, and there were fluctuations around the reference level. During the afternoon session, there were significant fluctuations, but overall, efforts were made to maintain the reference level. VN-Index decreased by 0.64 points (-0.05%), closing at 1,204.97 points. Trading volume decreased with 489.2 million shares matched on the HOSE.

VN30 group increased by 1.55 points (+0.13%), closing at 1,233.72 points. In the group, 11 stocks maintained their upward trend such as MWG (+2.9%), FPT (+2.6%), MSN (+1.8%), SAB (+1.5%), VNM (+1.1%), VIC (+1%). Conversely, 16 stocks declined, such as TCB (-1.8%), MBB (-1.3%), VIB (-1.2%), SHB (-0.9%), POW (-0.9%).

With the market's hesitant behavior, sectoral differentiation was quite clear with alternating increases and decreases, although the number of declining stocks outweighed the number of gaining ones. Technology and Retail groups continued to provide support for the market.

Foreign investors continued to be net sellers on HOSE, with a value of 466.4 billion VND. In particular, they sold strongly in FUEVFVND (-277.9 billion), DIG (-43.8 billion), FUESSVFL (-40.5 billion), GAS (-40.2 billion), GEX (-35.5 billion) ... However, they bought a lot at MWG (+209.6 billion), VND (+45.3 billion), TPB (+42.6 billion), HPG (+40.8 billion), KDH (+ 28.6 billion)....

The market hesitated near the 1,210-point level after a strong rebound session. Trading volume decreased significantly compared to the previous session, indicating that capital flow remains cautious as the market approaches resistance levels. However, the supply remains low and in a waiting state. The current state of hesitation is partly due to the market about to enter the April 30 holiday period and the psychology of waiting for information on the operation of the KRX trading system. The tug-of-war around the 1,210-point area may continue in the next trading session before clearer signals emerge. However, the market still carries the risk of stepping back as the supporting capital is at a low level. Therefore, investors should avoid chasing buys and maintain a reasonable portfolio allocation, while observing supply and demand dynamics at resistance levels to reassess the market's condition. Currently, it is advisable to consider profit-taking during recovery phases or restructuring portfolios to minimize risks.

## **Technical Analyst Recommendations**

The market is in a state of hesitation near 1,210 points after a strong increase. Exploratory developments before the 1,210 point area may continue in the next trading session before there are more specific signals. However, in general, the market still contains risks of setbacks due to low support cash flow. Therefore, investors need to avoid chasing and keep the portfolio proportion at a reasonable level, and at the same time observe supply and demand developments at the resistance zone to reassess the state of the market. Currently, investors should still consider recoveries to take profits or structure their portfolios to minimize risks.
