Market today: Balancing effort

- Although the supply force still exerted pressure at the end of the session, supportive cash flow still attempted to absorb the supply.
- This effort can help the market continue to be supported at 1,060 – 1,065 points of VN-Index and recover in the near future.

Under the pressure of profit-taking from the previous session, the market could not keep the green color at the beginning of the session but fluctuated during the session. At the same time, the development toward the end of the session was quite exhausted with selling pressure. In the end, VN-Index increased slightly by 0.2 points (+0.02%) and closed at 1,065.91 points. Liquidity decreased with 592.4 million shares matched on HOSE.

The VN30 group also struggled but closed the session in red, down 0.12%. Among the group, there were 13 gainers such as POW (+1.5%), STB (+1.5%), NVL (+1.1%), VCB (+1%), VHM (+1%)... By contrast, there were 13 losers, namely VIC (-2.8%), PDR (-1.4%), MWG (-1.2%), MSN (-1.1%), VPB (-1%)...

With the cautious and struggling movements of the market, many industry groups also hesitated and retreated slightly. However, there are still a few industry groups that have exciting developments to support the market such as Oil & Gas group, Livestock group, Construction group, etc.

Foreign investors were the net sellers on HOSE, with a value of VND 25.6 billion. They sold a lot at KBC (-43.2 billion), CTG (-42.7 billion), VNM (-39.9 billion), DPM (-19.7 billion), BMI (-16.1 billion)... On the other side, they bought a lot at HPG (+57.5 billion), VRE (+34.6 billion), VHM (+27.8 billion), PVD (+25 billion), VIC (+18.5 billion)...

With the state of profit-taking from the previous session, the market movement somewhat slowed down and showed a demand and supply exploration. Although the supply still exerted pressure at the end of the session, the cash flow attempted to support and absorb the supply. This effort can help the market continue to be supported at 1,060 – 1,065 points of VN-Index and recover in the near future. Therefore, investors can still expect short-term rallies of the market. At the same time, it is possible to consider holding or exploiting short-term opportunities in stocks with good technical signals and the state of attracting cash flow recently.

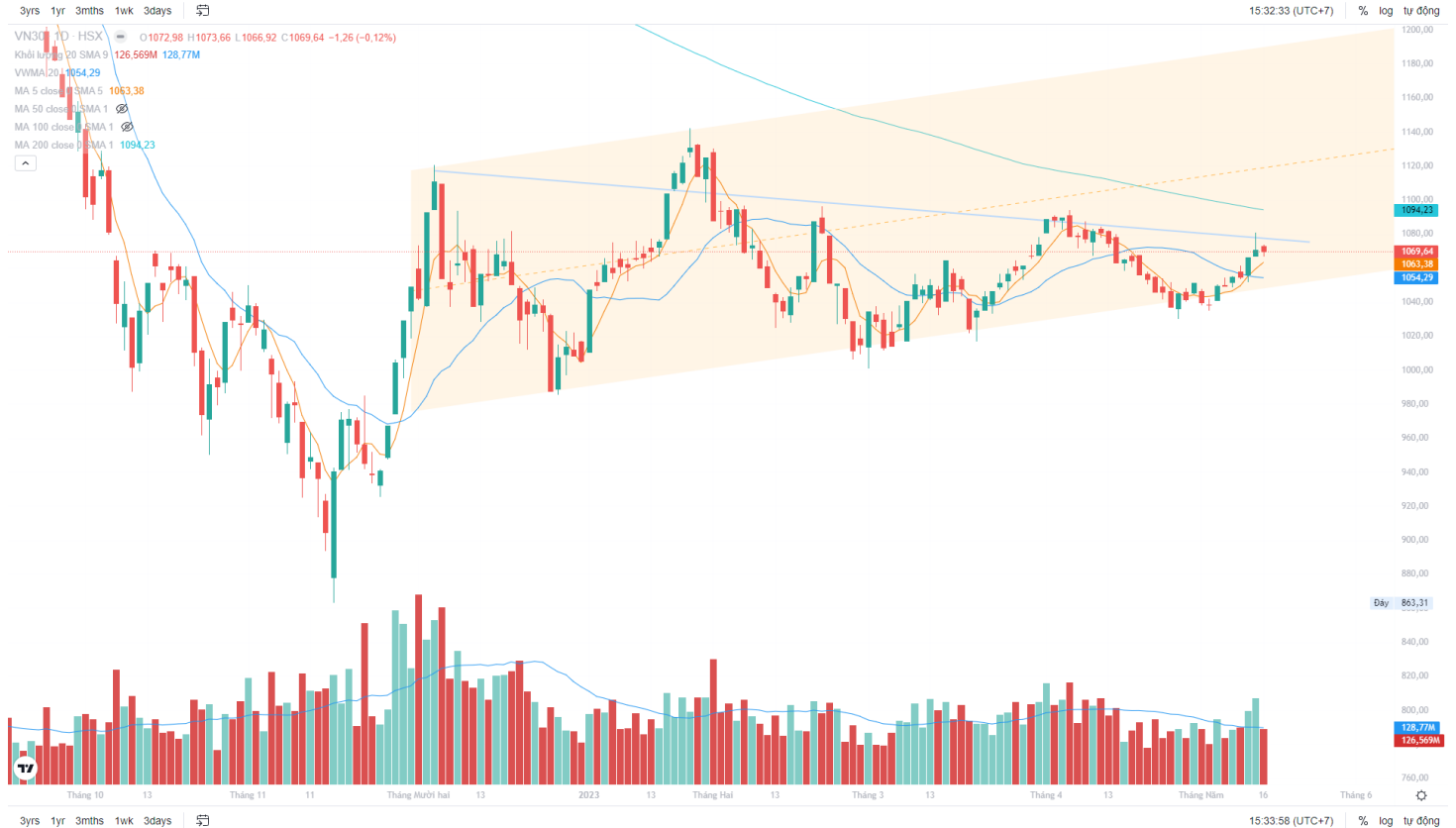
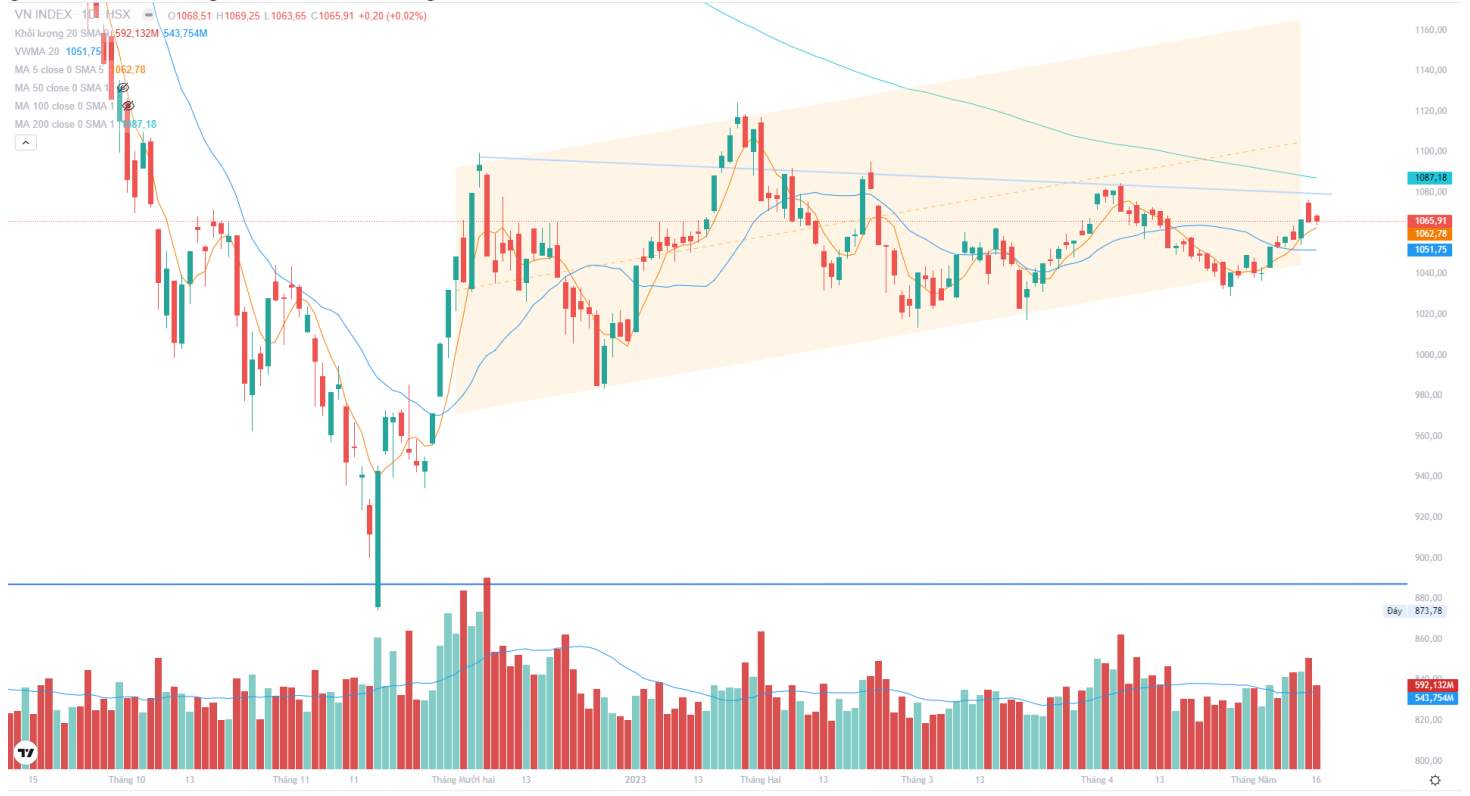
World steel market: Prices sliding amid skepticism on China’s demand outlook

Technical Analyst Recommendations

The market's movements were still cautious after yesterday's drop. The indexes could not extend their early gain and continued to retreat. However, the support move at 1,060-1,065 points of the VN-Index temporarily helped the market to restrain the decline. It is expected that the market will continue to be supported at 1,060-1,065 points of VN-Index and recover again in the next few sessions. Therefore, investors can continue to consider holding or waiting for short-term opportunities in stocks with good technical signals and attracting cash flow.
